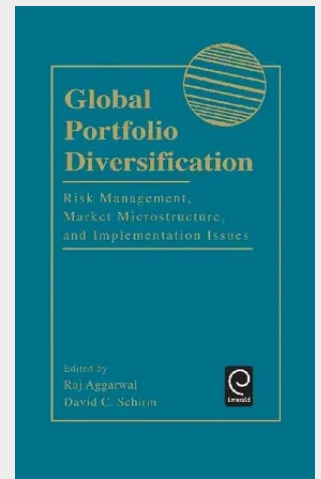


## Global Portfolio Diversification
