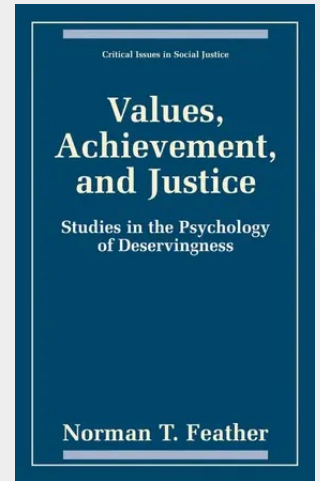
Studies in the Psychology of Deservingness
