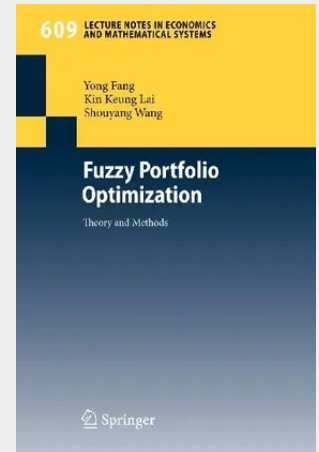


Fuzzy Portfolio Optimization
